Cruise Passenger Charge	Fee imposed on the cruise line for each passenger arriving during a port of call or in transit in Antigua, regardless of whether the passenger disembarks.	\$12.10
Security Fee	The fee levied on cruise lines for the provision of security services to ensure the safety and protection of passengers, crew, and vessels while they are at the port of call or in transit through the port.	\$1.50
National Solid Waste Management Authority (NSWMA) Tax	Environmental levy collected on behalf of the Government of Antigua and Barbuda for each passenger that is arriving on a port of call operation / in transit or homeporting in Antigua, whether the passenger disembarks or not.	\$1.50
Homeport Facility Fees	This fee is applied when a cruise ship uses the port as its homeport, meaning it begins and/or ends its voyages at Antigua Cruise Port. This fee covers the operational costs associated with providing terminal services and amenities for both passengers and crew during embarkation and disembarkation processes.	\$5,000.00 (Per call)
Baggage Screening	Fee charged to the Cruise Line for each passenger on a homeport operation. This charge covers the cost of baggage handling and screening of luggage through the terminal for homeporting vessels and include portorage (available upon request).	\$20.00 (Roundtrip)
Gangway Fee	This fee applies when cruise ships require the use of a gangway. It covers the setup and removal of the gangway on the vessel, facilitating the embarkation and disembarkation of passengers and crew while docked at Antigua Cruise Port.	\$100.00 (Per use)
Crowd Control /Security Barriers	The cruise line is charged a daily fee for the provision of barricades utilized to manage and secure areas around cruise ships.	\$500.00 (Per day)
Lay-Ups / Technical Calls	Security Charge: This fee covers security services provided to ensure the safety and protection of the ship and its facilities during the lay-up or technical call period. Gangway Use Charge: This fee is for the use of gangway services, which provide safe passage between the ship and the port for crew members and personnel involved in the technical activities.	\$250.00 (Per day)  \$100.00
Cleaning / Sanitizing Fee	A charge applies for cleaning services necessary due to ship operations requiring specific cleaning procedures. This fee covers standard cleaning services and excludes any costs associated with specialty chemical treatments.	\$30.00 (Per hour)

<b>PORT ACCESS</b>	<b>Port Identification Cards and Permits are mandatory for all individuals seeking access to the Antigua Cruise Port facility.</b>	<b>PORT ACCESS</b>
Annual Permits	This is approved for companies who will access the restricted areas at ACP Facility. This permit must be renewed annually.	\$280.00 Plus ABST
Port Pass	This is for approved personnel of approved companies who will access the restricted areas and granted a permanent or temporary pass.	\$18.50 Plus ABST
Government Employee	This ID is for government personnel who are stationed or visit the facility regularly. There is no fee for the ID and must be renewed annually.	N/A
Visitor Pass	This ID is for all authorized visitors to the facility. There is no fee for this access.	N/A
Replacement	If an ID card is lost, damaged, or stolen, a letter must be submitted to the ACP Security Office. There is a Replacement ID fee applicable.	\$50.00 Plus ABST
Vehicle Registration	Vehicles such as garbage trucks and delivery vans that frequently access the port (more than 5 times per year) will be subject to an annual fee.	\$250.00 Annually
Vehicular Access - Small	Any small vehicle (Car, Pickup truck) or any vehicle carrying passengers, will be charged per entry into the facility. <b><i>These vehicles must be pre-registered, and fees paid prior to accessing the port</i></b>	\$50.00
Vehicular Access - Large	For all large vehicles (Trucks, Vans), fees will be charged on a per-entry basis. <b><i>Prior registration and fee payment are mandatory before accessing the port facilities.</i></b>	\$100.00
